

## **PRIVACY POLICY**

### **Information**

Information provided pursuant to article 13 of General Data Protection Regulation (EU Regulation 2016/679). Information is only for www.motorenergy.it site not for others web site eventually linked by the user.

### **Data controller**

In the process of following consultation of this web site, data pertaining to identified or identifiable persons may be processed. The "data controller" is FIAMM Energy Technology S.p.A., with registered office in Viale Europa, 75 - 36075 Montecchio Maggiore (VI).

### **Premise where data is processed**
